

## Overview of BFZ Reporting.



### The Key Lesson of 100K Homes

The 100,000 Homes Campaign proved that communities could increase their housing placement rates, but this did not automatically reduce homelessness.



### The Challenge of Counting Down

Built for Zero is designed to help communities **count down to zero** — a more complex challenge that requires a clearly defined end state for communities to shoot for.



### **Racial Equity Indicators**

# SYSTEM DECISIONMAKING POWER

Black, Indigenous, and People of Color (BIPOC) at all levels of the homeless response system have decision-making power to influence the design of the system.

### LIVED EXPERIENCE

BIPOC receiving services from the homeless response system have experiences that preserve their dignity and have their needs met in a timely manner.

#### **QUALITY DATA**

All people experiencing homelessness have access to the system and are known by name in real-time. Communities accurately collect data around race and ethnicity.

#### SYSTEM OUTCOMES


Communities close all racial/ethnic disproportionality in housing placements, returns to homelessness, and the average length of time from identification to housing by improving outcomes for BIPOC who experience homelessness.







## **Getting from Data to Quality Data?**

#### **FULL COVERAGE**

- All agencies and programs are represented (linked systems involved)
- List includes households sleeping in shelters, on the streets and/or in unsafe/unstable living conditions
- Comprehensive geographical reach
- Strives to account for/include everyone no matter how they show up in your system

### PERSON-LEVEL DATA

- Each household has an entry that includes their name, history, health and housing needs
- Each household and person can be followed through the system
- Demographic level data is collected through self-determination

#### **RELIABILITY**

- Data balances month over month, just like your checkbook
- Changes in actively homeless numbers are accounted for in inflow + outflow

### **REGULAR UPDATES**

- List is updated monthly, at a minimum (goal of real-time)
- As household's housing and population status changes, so do their list entries



## How do we Assess if Communities have Quality Data?

## **Two components:**



**Qualitative Measure** 

(Perfect Score on BNL Scorecard)

All items on the scorecard have a "Yes" response



**Quantitative Measure** 

(Reliable/Balanced Data)

This requires a minimum of 4 months of reported data to calculate

\*3-month\* data reliability within +/- 15% margin



## **Monthly Reporting: Actively Homeless**

#### **ACTIVELY HOMELESS**



**DEFINITION:** As of the *last day* of the reporting month, the number of actively homeless households on your By-Name List

#### **NOTES:**

- Actively homeless households may reside in shelter, transitional housing, or in a location not meant for human habitation (on street, beach/riverbed, in car, etc.).
- Actively homeless households may have received a voucher or subsidy. However, if they have not yet moved into a
  permanent housing unit, they should still be counted as actively homeless.


