⚠️ The U.S. is short 4M homes. Millions of families pay over half their income on rent. In this moment, the last thing we can afford is losing stable housing for the people who need it most.

We see the stakes clearly: we are in a national affordability crisis.

The country faces a shortage of more than 4 million homes, while millions of families pay over half their income just to keep a roof over their heads.

In this environment, preserving stable housing is not optional — it is essential for protecting our neighbors, our community, and our local economy.

With rising homelessness and soaring rental costs, policy choices must strengthen housing security, not undermine it.

HUD's new rules could take away housing from 170,000 people — including seniors, people with disabilities, and Veterans. That would force thousands back into homelessness and wipe nearly \$2B from local economies.

We're deeply concerned about the risks created by HUD's new funding rules.

These changes could put housing for more than 170,000 people at risk in 2026 — including seniors, people with disabilities, and Veterans who have already overcome homelessness.

If this support is withdrawn, we would feel the impact immediately:



Tens of thousands could be pushed back into homelessness



Local businesses, hospitals, and emergency services would face even more strain



Nearly \$2 billion in reliable rental payments would disappear from local economies — hitting small mom-and-pop landlords especially hard

Stable housing keeps our neighbors safe and local economies strong. Weakening that support would have serious and lasting consequences.

More than 170,000 affordable homes could suddenly become unaffordable for people living on fixed incomes. And the ripple effects would be felt across entire communities:

-  Increased shelter demand and more people pushed into homelessness
-  Higher costs for local governments and health systems
-  Strain on downtown businesses and overall community well-being

These consequences would destabilize both people and places. Protecting stable housing is essential for keeping our community strong.

Our community supports Community Solutions' call for action: Congress must renew all CoC grants for 12 months to protect housing, prevent harm, and keep local economies stable. Federal policy must reflect reality — flexible, practical, and focused on outcomes for our neighbors.

We support what Community Solutions is calling for in response to HUD's new funding rules:



- 1 Immediate congressional action: Congress should direct HUD to renew all CoC grants expiring in 2026 for a full 12 months.

This renewal would:

-  Preserve housing for tens of thousands of Americans
-  Give us time to assess policy changes and prevent harm
-  Protect local economies from the abrupt loss of rental support

- 2 Federal policy that is focused on outcomes.

Communities like ours need flexible, practical tools that:

-  Preserve existing homes for people struggling with rising housing costs
-  Prevent returns to homelessness rather than reacting after people fall into crisis

We support reform but it must be centered on keeping people housed and reducing homelessness, not driven by bureaucratic deadlines.

Our community needs solutions grounded in reality, centered on stability, and designed to protect both people and places.
